CALL MEETING TO ORDER / WELCOME / DELEGATIONS

Mayor Dooley called the meeting to order at 7:00 p.m., in compliance as per Provincial Health Authorities, Alert Level 2 and the Dept of ECCM, with Social Distancing practiced by all in attendance. Two registered delegates in attendance.

1. President/Chair, CBN T'Railway from Brigus Junction to Old Perlican, in attendance to discuss Off-Road Vehicle usage on the CBN TransCanada Railway within Victoria's municipal boundary, the following was noted:

- The group is reaching out to communities along the original CBN Railway requesting permission to use the original CBN Railway for off-road vehicle travel, their efforts are widely recognized and have been successful in most area. Victoria is one of the two remaining towns on their list.
- Recognized Victoria is unique from other towns along the CBN Railway as much of the old railway track runs through the middle of town, which is residentially developed.
- Noted Off-Road vehicles are problematic everywhere and their efforts of developing and cleaning up sections
 of the CBN Railway, claims of assisting with decreasing the number of off-road vehicles using main
 highways and town roads; further stating these efforts are to the town's benefit and can increase recreational
 activities within towns and may also assist with increasing tourism.
- Alternative areas around Victoria were mentioned, i.e.: NL Power Transmission line through the west-end of Victoria to Rocky Pond is listed for trailway use by off-road vehicles with minimal work required, which is regularly maintained by the company and tree-trimming companies. MMTRA has already built and installed several bridges over brooks, streams, and some wet-land areas along this same area. Also, Old Salmon Cove Road from top of Ridge to Salmon Cove, which has been recently brush-cleared and used regularly. The possibility of constructing a bridge over the brook exiting the town's lagoon system was also mentioned.
- Another route mentioned was along the back of White's Sub-division; CBN Chairman stated some wet-land areas would be expensive to develop.
- Stated, the Recreation Department in the Town of Carbonear is currently looking at a plan submitted by the CBN T'Railway to investigate the possibility of allowing off-road vehicles to travel to along the beach area. The Town of Bay Roberts is developing a taskforce to investigate a certain area of town for similar approval. Council was encouraged to reach out to the two towns if they had any questions or to inquire as to the progress to date.

It was reaffirmed it was outside Council's jurisdiction to approve for off-road vehicles to use Provincial Highways and it was asked that Victoria be left out of their development plans until other major towns, such as Carbonear/Bay Robert's, have completed their investigations and have replied as to their findings and final decisions on the matter. It was also asked that the group find an alternate route around Victoria before Council can give serious consideration to an off-road trail within Victoria's municipal boundary.

- Mayor Dooley's closing remarks: What was once the CBN Railway through Victoria is now extensively developed into residential areas and covered by the town's development plan and regulations, further citing these areas may not be considered for approved off-road vehicle usage. He also mentioned the guardrail at the end of OTR and provided an explanation why it was installed and should not be removed.
- Chairman's closing comments: Feels this venture can be positive for Victoria and is open to exploring other alternate routes around other than through the center of Victoria. Left the meeting at 7:27 p.m.

2. Property Owner #40 Bottom Loop Rd – Letter of Complaint regarding charges for minimum Property Tax and full Water/Sewer Fee for serviced lot. Property Owner was advised this matter was of a confidential nature and could be discussed in a privileged meeting; Owner requested to proceed with discussion in public council meeting. The compliant was discussed in detail, with Council confirming the charges were appliable and in compliance with the town's 2021 Tax Structure and Municipalities Act, 1999; therefore, the request for an adjustment or decrease in the amount charged was denied. Resident stayed for the council meeting.
